Nii Anumle Oyanka is also a descendant of King Behanzin, King Agbakalolo, and Queen Tassi Hagbe who are all of the Ancient Dahomey Amazon Royal House of Benin Kingdom.

Asafoatse Nii Adama Djata is currently the Founding Royal High Priest of the Okonfo Atchingali Temple State, World Grand Commander of Okonfo Atchangali Temple, Noryaa Mantse of the Ga Abola Piam Royal Clan, First Appointed King of the Anamase Royal Alliance Council, Founding Grand King of the Anamase Royal Council in the Diaspora, Founder and Grand Master of Anamase Royal Temple, and Founding Ambassador of the Anamase Coalition.

Master Dossou Roi Dossavi-Yovo, born in 1985, is a prominent figure in the vodoun culture hailing from Ouidah. He is the eldest child in his family's lineage, which boasts a rich royal history. His grandfather, Dagbo Hounon, was the first crowned head of Ouidah and was known for his powerful abilities, including the ability to cross sea water. Dagbo Hounon was instrumental in establishing the Vodoun festival in Ouidah, which takes place every year on January 10. The sacred forest of Ouidah is a significant aspect of their culture, housing powerful geniuses that hold great value and importance to the community. One of the most revered figures in their lineage is King Toffa, who was known for his wise ideas and ability to bring about positive change. King Toffa's reign was marked by the presence of the powerful genius Kpena, who raised the reputation of their family name far and wide. After King Toffa's passing in 1996, he designated Master Dossou as his successor, ensuring that the legacy of their royal lineage would continue. As the current King Dossou, he continues to uphold the traditions of his ancestors and carry on the powerful legacy that has been passed down through generations. His name is synonymous with respect and reverence in the vodoun culture, a testament to the impact of his family's history and lineage. King Dossou would aid Nii Adama Djata in establishing a merged vodoun royal council called, "The Royal Council of Adama Djata Under the Principal Egougoun of Adjanna" composed of Nii Adama Djata, two other Kings, with Royal dignitaries from various surrounding villages to aid in operational affairs of Toffa Royal Palace and Temple in Ouidah which was newly purchased property of Asafoatse Nii Adama Djata and a building that had to be renovated and updated. This would be completed along with a series of festivals such as egougoun and zangbeto festivals composed of the main dignitaries of the area. With the aid of King Dossou helping to compose these events, this would lead to Nii Adama Djata's promotion as, Founder of Toffa Royal Palace and Temple, Diplomatic Ambassador of Vodoun under the Ouidah Minister of Culture, appointed President of the Dignitaries of Ouidah Commune, and appointed current Crowned Head of Vodoun in Ouidah Commune.
